

COVID-19 by the Numbers


- In Fairfax Health District



Low	0 – 9.99	0 – 4.99%


Community Transmission Level



Implement Layered Multiple Prevention Strategies

Nine Key Prevention Strategies:

- 1. Promoting vaccination
- 2. Consistent and correct use of masks
- 3. Physical distancing
- 4. Screening testing
- 5. Ventilation
- 6. Handwashing and respiratory etiquette
- 7. Cleaning and maintaining healthy facilities
- 8. Staying home when sick and getting tested
- **9.** Contact tracing in combination with isolation and quarantine.

Possible Side Effects

Your child may have some side effects, which are normal signs that their body is building protection.

On the arm where your child got the shot:



- Pain
- Redness
- Swelling

Throughout the rest of their body:



- Tiredness
- Headache
- Muscle pain
- Chills
- Fever
- Nausea

Where can my child get a vaccine?

- Most sites will be providing vaccine by appointment only at this time. These include:
- Pediatric and Family Medicine Providers: call your child's doctor to make an appointment.
- Pharmacies, grocery stores, and urgent care facilities: visit vaccines.gov (www.vacunas.gov) to search for a vaccine appointment.

New Protocol for Student Sent Home Sick

FCPS GUIDANCE FOR STUDENT SENT HOME WITH COVID-like ILLNESS

The FCPS Guidance for Students Sent Home with COVID-like Illness will replace the Return to School Form effective October 4, 2021.

Students may return to school when their symptoms have improved and they have not had a fever without fever-reducing medications for at least 24 hours, <u>AND</u> have at least one of the following:

Proof of a Negative COVID-19 Test

- PCR (test result from lab or physician)
- Rapid (test result from lab or physician)
- Home test (picture of negative home test result <u>and</u> note from parent a) attesting the result is for the specific child and b) attesting to the date the test was administered; actual used tests should not be submitted to the school for health and safety reasons)

OR

Physician's Note

Note from a healthcare provider following a clinical evaluation stating the cause of symptoms is not COVID-19 and clearing the student to return to school.

NOTE: If the student has been identified as a potential close contact or close contact to a positive case, the student will need to follow guidance provided by the health department and the options listed above alone will not be sufficient for the student to return to school.

School Investigation Terms

Pause

 Temporarily excluding potential staff and student close contacts from onsite activities to give the FCHD time to complete case and contact investigation.

Quarantine

Time frame in which identified close contacts must be excluded from onsite
activities. All identified close contacts must quarantine through 14 days from the last
date of exposure to a positive case.

Isolation

 Time frame in which case must be excluded from onsite activities. All cases must isolate through 10 days from symptom onset (positive specimen collection date if asymptomatic), and fever free for 24 hours without the use of fever-reducing medication, and all other symptoms improving or resolved

School Investigation Process – Contact Tracing


- Early communication between FCPS reporter and Containment Team
- Digital Vaccination Verification
- Digital communication option with families regarding child quarantine

Neighborhood and Community Services (NCS) Coordinated Services Planning (CSP)

Coordinated Services Planning (CSP) background:

Established in 1997 to provide efficient and coordinated access to community-based and public human services


Access is provided through a unique system of social work services delivered in a call center environment

CSP coordinates with Fairfax County, Community Based Organization (CBO), Non-Profits, Faith Based Organizations to connect community members with resources that promote self-sufficiency and enhance well-being

What Does CSP Do?

CSP provides callers
direct access to a
specialist who will listen
to the expressed need,
assess the situation,
explore possible short
and long term solutions,
and coordinate resources
within the community.

How Does CSP Work?



- Five teams of specialists, within the human service regions
- Calls are answered by an available specialist, regardless of the community members location
- Two intake lines: English and Spanish
- **Bi-lingual staff:** Amharic, Chinese (Cantonese | Mandarin), Creole (French), Dari, Farsi, Hindi, Kannada, Korean, Pashto, Punjabi, Somali, Spanish, Tamil, Tigrinya, and Urdu. (language interpretation also available)
- Hours of operation: 8:00 am 4:30 pm, Mon. Fri at 703-222-0880

Who Does CSP Serve?

- Individuals and Families
- Human service professionals
- Anyone seeking information and referral
- Some services are limited to Fairfax County community members
- Specific services may have income requirements
- Callers from other jurisdictions are directed to their local Information and Referral Agency, or 211 Virginia for connection to community services




What to Expect When You Call CSP



- A specialist will answer the call and complete a broad-based assessment and service plan with the community member
- The length of call can vary from a few minutes for information and referral to thirty or forty minutes for callers with multiple needs
- Community member information, including assessment, service plan, needs/outcomes and referral sources, will be documented in ASSIST database
- Depending upon the need, some documentation may be requested


OUR PARTNER AGENCIES IN HEALTH AND HUMAN SERVICES (HHS)
